Therefore, in consideration of the lease of the space and other good and valuable considerations, the parties agree as follows:

1. Vendor agrees to pay Stanton Chamber of Commerce fee (\$25) per season as rent for the 2023 Season
2. Vendor agrees to hold harmless the Stanton Chamber of Commerce and all other Stanton entities for: ALL claims, demands, actions and causes, together with costs and expenses, including attorney fees of defending such claims, resulting or arising from claims, loss or damage to property or persons for injury or death, which may result from the installation, occupancy, operation, use, maintenance, or repair of any stand, bay, booth, installation or structure of any kind.
3. Vendor agrees to hold harmless the Stanton Chamber of Commerce and all other Stanton entities for: ALL claims, demands, actions and causes, together with costs and expenses, including attorney fees of defending such claims, resulting from consumption of products, food or goods which are sold, received, obtained, or acquired from any booth or other installations of any kind of the vendor.
